

ASPEN LIMITED WARRANTY

Models Covered: CA, CB, CC, CE, CM and CP Series Evaporator Coils

Aspen Manufacturing I, Ltd. ("Aspen") warrants to the **original registered owner** and his or her spouse ("owner") that Coils sold to them shall be of a merchantable quality, free of defects in material or workmanship, under normal use and service for a period of **ten (10) years** from date of manufacture OR ten (10) years from date of installation, NOT to exceed eleven (11) years from date of manufacture. If a claim is made during the eleventh year, documentation of installation date must accompany the claim.

This warranty applies only if:

- 1) The unit was manufactured April 2007 and beyond.
- 2) The unit is installed in an owner-occupied, single family residence, and,
- 3) The unit is installed in conjunction with a split system air conditioner or heat pump to which it is properly matched by the installer, and,
- 4) The unit is properly registered with Aspen within 60 days after the original installation. To register, return the warranty registration card packed with the coil.

If the above conditions are not met, then the Coil is warranted for a period of 5 years from date of manufacture.

The warranty period begins on the date of the original installation. If that date cannot be verified, the warranty period begins on the date of manufacture. Date of manufacture is coded in the first three digits of the serial number, e.g. D07-00017662 = April 2007

A=Jan B=Feb C=Mar D=Apr E=May F=Jun G=Jul H=Aug J=Sept K=Oct L=Nov M=Dec

For warranty credit, a state certified or licensed contractor must return the defective part to an Aspen distributor. Coils covered by this warranty and found to be defective upon examination at an Aspen factory-authorized service center will, at Aspen's option, be repaired or replaced and returned to the buyer via lowest common carrier. Correction of such defect by repair or replacement, return via lowest common carrier, and, in cases of Coil defect, the payment of a fifty-dollar (\$50) labor allowance credit to the buyer, shall constitute full performance by Aspen of its obligation hereunder.

Every claim on account of Breach of Warranty shall be made to Aspen in writing within the warranty period specified above, otherwise such claim shall be deemed waived.

Aspen is not responsible for:

- 1) Damage or repairs incurred for repairs of start-up refrigerant leaks, since Coils that are not pressurized should not be installed.
- 2) Damage or repairs associated with a Coil that has been removed from the location where it was originally installed.
- 3) Damage or repairs required as a consequence of faulty installation or application.
- 4) Damage as a result of floods, fires, winds, lightning, accidents, corrosive atmosphere or other conditions beyond the control of Aspen.
- 5) Use of components or accessories not compatible with this unit.
- 6) Products installed outside the United States or Canada
- 7) Normal maintenance as described in the installation and operating manual, such as cleaning of the coils.
- 8) Parts not supplied or designated by Aspen.
- 9) Damage or repairs required as a result of any improper use, maintenance, operation or servicing.
- 10) Changes in the appearance of the unit that does not affect its performance.
